Competition Rules

1. The Junior Division is open to competitors who currently reside in Kansas or Oklahoma, or past attendees of the Summer Music Festival. Junior Division competitors must also be 12-18 years old as of January 1, 2020.
2. The Senior Division is open to all current Southwestern College students of any major.
3. The competition is open to string, wind, percussion, piano and voice students.
4. Competitors must be available for the following: the April 20th Rehearsal (7:00-8:00pm), the April 25th Dress Rehearsal (1:00-2:00pm), and the April 26th concert (3:00pm).
5. First place winners who are not available to rehearse and perform will forfeit their award.
6. Be prepared to perform a solo piece which has an available orchestral accompaniment. The selected movement(s) must be played in its entirety. Memorization is optional.
7. 1st Place winners may not audition for the same division in future years.
8. All auditions must be played in person for the audition committee.
9. Transportation is not provided.
10. Competitors must submit the application material and pay the application fee by the deadline (January 24, 2020) in order to participate in the competition.
11. The application fee is non-refundable.
12. The dates, times and locations of the competition, rehearsals, and performance are non-negotiable.
13. If the competition is canceled due to inclement weather, an alternative date may be provided.
14. Auditions will be scheduled during the day of February 22nd at Southwestern College.
15. Competitors will be notified of their audition time at least 2 weeks after the application deadline.
16. Competitors must supply their own accompanist for the audition.
17. Competitors will be judged on the mastery of their solo piece, their overall performance technique, and their stage presence.
18. Audition results will be communicated within 2 weeks of the audition date. The decision of the audition committee is final.
19. First place winners of both divisions will be invited to perform with the South Kansas Symphony on their April 26th concert.
20. First, second and third place winners of the Junior Division and First and Second place winners of the Senior Division will be recognized at the April 26th concert.
21. Finalists must file a W-9 form with Southwestern College prior to receiving their monetary award. Forms will be emailed.
22. By participating, the competitor gives consent to the South Kansas Symphony to take or use photographs, digital images, or recordings in news releases and/or marketing. These might appear in print or online.
