8. Describe your institution's most successful strategies in meeting the assurances listed above:

Southwestern College offers a graduate level alternative licensure degree program which focuses on the pedagogy and instructional practices most beneficial to success in the classroom. Students in the alternative licensure program must meet specific eligibility criteria as set by the Kansas Department of Education. Once hired by a school district to teach and granted a restricted license to teach, students enrolled in this alternative pathway experience a combination of rigorous coursework parallel to and in conjunction with their full-time teaching assignment. Program outcomes align with the identified needs of local education agencies, the needs of schools, and address the instructional decisions new teachers face in the classroom. Course work includes helping students understand and meet the needs of diverse student population through exposure to diversity, special education, and classroom management. Approximately 60 hours of mentoring and induction support are provided annually to students in the alternative pathway through



an assigned experienced mentor teacher who also teaches in the same content area and through a college faculty supervisor. Data collected from those participating in the restricted licensure program, as well as data collected during supervised clinical field work and classroom teaching experiences indicate Southwestern College alternative licensure students are successful in meeting the assurances as listed.

Alternative licensed teachers are required to use a variety of technology applications in course work when submitting assignments, projects, and teaching activities. Additionally, students complete and submit lesson plans in various courses which require incorporation of technology to meet NET-S standards. Because students enrolled in the Masters of Teaching alternative licensure pathway are employed to teach full-time in the classroom, these students are required to use the technology necessary to be successful within the district they are assigned to teach. In order to complete assigned course work, a variety of software and technology applications are explored and used by students when completing assignments and making presentations. During the last semester of this program, a teacher work sample is completed which requires teachers working under a restricted license to collect, manage, analyze, and present data addressing the performance of and growth in student learning. Data analysis experiences are facilitated by college faculty, mentor teachers, and as required to meet building and/or district data collection and analysis requirements. As part of their full-time teaching duties, students access school-based technologies that include the use of web-based software products that allow pre-service teachers to present and manage data for purpose of communication to children, their parents, and the larger school community.

#### a. Teach students with disabilities effectively

All students enrolled in the Southwestern College alternative program must take and pass Introduction to Special Education. This course is designed to provide a solid grounding in understanding the developmental and learning characteristics of students with all types of exceptionalities. The contemporary concepts and evidence-based practices necessary to prepare special educators for teaching students with disabilities will be presented to students. Course content includes the philosophical, historical, and legal foundations of special education and ensures an understanding of the mandate to provide students with appropriate access to the general education curriculum. Important ideas around least restrictive environment, accountability, inclusive practices, professional collaboration and response-to-intervention are integrated. Additionally, because students in this alternative program are working under a State-provided restricted teaching license, they are working with students with exceptionalities on a daily basis. In addition to implementing pedagogy and instructional strategies to meet the needs of diverse learners, students in this program also work collaboratively with special educators assigned to serve students within their classrooms.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Students in the Southwestern College alternative pathway are earning this degree while working under a restricted license and teaching full-time. As a full-time educators, students are required to participate as a member of individualized education program teams as part of their regularly assigned building duties.

#### c. Effectively teach students who are limited English proficient.

Students in the Southwestern College alternative pathway are earning this degree while working under a restricted license and teaching full-time. As a full-time educators, students are required to meet the needs of all learners which includes effectively teaching students who are limited English proficient. Students in this program have an assigned mentor teacher who works in the same content areas as the student. This mentor helps the student adjust lesson plans to better meet the needs of diverse learners. Additionally, students are required to take content area literacy which helps students develop instructional strategies to address limited English proficient students.

Southwestern College students enrolled in the alternative licensure program receive a Master's of Arts in Teaching from Southwestern. Students enrolled in this alternative licensure program are K-12 teachers, working under a Kansas restricted teaching license, with full-time responsibilities as the instructor of record. The Restricted Teaching License Alternative Pathway is intended to respond to school districts' needs in hiring qualified, licensed teachers. It is designed to recruit mid-career professionals who have a bachelor's, master's degree, or equivalent coursework in a content area they want to teach and are seeking a career change. Heritage language speakers with a bachelor's degree or higher can also utilize the restricted licensure to teach their native languages. This pathway provides an opportunity for these individuals to have immediate access to start teaching under restricted license while completing professional education pedagogy course work to become fully licensed. While working under a restricted license and until degree completion, a district or building assigned mentor teacher and college supervisor assist to integrate the teacher as a team member supporting all learners. Offering this program at the advanced level provides rich, intellectually diverse learning experiences that address the needs of the local education agency in which they are employed. Per Kansas regulations, candidates are eligible to work under a restricted license while seeking an initial teaching license, and complete graduate level degree requirements if the the following requirements are met: 1. The candidate holds a Bachelor's degree or higher from a regionally accredited university. The degree or equivalent coursework must be in a regular education content area the candidate wants to teach, OR be a heritage language speaker, 2. The candidate must hold a GPA of 2.75 from the last 60 semester credits hours of college coursework completed, 3. The candidate must have a passing score for the Praxis II content assessment in the content area, AND 5. A supervised practical training experience must be completed under the collaboration of the supporting institution and hiring school district before restricted teaching license can be issued.
